<u>PEP Memorandum #13</u> RESPONSE DEADLINE: April 28, 2017

The Prison Education Program (PEP) joint annual plan provides the tool for colleges and prisons to collaboratively assess the needs for community college programs delivered at the prison facilities in the upcoming fiscal year. This includes physical and instructional resources necessary as well as associated tuition, registration, and testing fees.

Please submit the attached Joint Annual Planning document for all College and Career Readiness, Workforce Continuing Education, and Curriculum courses planned for fiscal year 2017-2018 by <u>April 28, 2017</u>.

The purpose of joint annual planning is to develop a proposed schedule of community college courses for each facility and to calculate the Prison Education Program (PEP) funding necessary to support those courses in Fiscal Year 2017-2018. The intent of these planning discussions goes beyond the calculation of funding support needed from North Carolina Department of Public Safety (NCDPS) budget allocations to cover student registration and testing fees. The process also involves colleges working with local prison staff to appropriately plan all necessary instructional resources to effectively execute programs requested by NCDPS. Prior to completing this document, college and local prison staff should meet to discuss the purpose and content of this planning document.

This joint plan should be signed by the college president, prison superintendent, and local PEP points of contact. We ask that the community college point of contact (designated by the college on the attached form) be responsible for ensuring that a signed hard copy **and** an electronic copy are submitted by <u>April 28, 2017</u>
