Subject: Prison Education Program Validation Form - FY 2013-2014

Attached is your Prison Education Program (PEP) State-Level Validation Form for the current fiscal year outlining the total funding available to pay tuition and fees for inmates taking community college classes in your local Division of Adult Correction (DAC) prison facility. **The attached form should be signed by college and prison management and returned to the System Office via mail by September 20, 2013**. The signatures confirm that the college and prison have jointly planned a schedule of courses for 2013-14 and that billing for these courses/CRC fees/GED testing will not exceed the attached allocation. Please note the following:

- The form includes information on funding to cover GED batteries and scoring for the time period of January 1 June 30, 2014, when the Division of Adult Correction must start paying for GED testing. <u>Additional information on GED testing in the prison will be forthcoming</u>. Do not use the GED allocation to pay for any course tuition/fees or CRC assessment fees.
- The attached form identifies the specific course IDs that DAC has approved; however, separate State
  Board of Community Colleges' approval is still necessary to earn FTE on correctional education
  courses. Always confirm that such approval is on file prior to offering any course in a prison.
- Detailed Joint Annual Plans do <u>not</u> have to be submitted to the System Office this year; however, it is expected that colleges and prisons will jointly agree to a detailed plan locally to ensure that programming can be offered within the parameters of the attached Validation Form. Once the attached document is signed, please <u>keep a copy for your use</u>, and **mail the signed original to Tracy McPherson (NCCCS, 5003 Mail Service Center, Raleigh, NC 27699-5003) by September 20, 2013**. You may begin using the new form for billing purposes immediately once it is signed locally.
- If revisions need to be made to the attached course offerings list, please notify Tracy McPherson or Tony Reggi by email as soon as possible so that we may issue an updated validation form if necessary.
