AMENDMENT 1 FOR IFB 50-NCCCS-07052018 BAFO No. 1, DIT #500005-000

THIS AMENDMENT 1 is executed between the **North Carolina Community College System**, 200 West Jones Street, Raleigh, NC 27603 (NCCCS), and **CampusWorks, Inc.**, 1767 Lakewood Ranch Blvd #305, Bradenton, FL 34211 (Vendor). Collectively, NCCCS and Vendor are hereinafter referred to as "the Parties".

The Parties acknowledge that they executed the original contract, IFB 50-NCCCS-07052018 BAFO No. 1, DIT #100400 on December 16, 2019, for Vendor to provide Managed Services Support as addressed in the referenced IFB (AGREEMENT). The initial term of the contract was for three (3) years beginning December 16, 2019, through December 31, 2022, at a cost dependent on level of services provided.

The Parties now agree to amend the AGREEMENT as follows:

- The AGREEMENT is extended for an additional one-year term beginning January 1, 2023, through December 31, 2023, for the Vendor to provide Managed Services Support as addressed in the referenced IFB.
- 2. For the extended one-year term, Vendor's blended hourly rate is increased from \$135/hour to \$171/hour for the requested services as detailed in the AGREEMENT. The price charts on Page 4 and Page 6 of the AGREEMENT are shown below respectively to reflect the new rate of \$171/hour.
