The individual users (state agencies, institutions and universities) will work with the chosen vendors on a case by case basis. Users are free to use any of the approved vendors. The approved vendors collect the outstanding debt from the debtor. The vendor then sends the entire amount collected to the state agency, institution and/or university.
