- RE: FIP Course Updates: Revised Blue Sheet including Removal of FIP-4214 Fire Arson Detection

This memo is a request for action and an update related to Workforce Continuing Education courses with an FIP (Fire) prefix. *Please share on your campus, as appropriate*.

- **<u>Request for Action</u>**: Please run XUIC and XULU as soon as possible to download a change to FIP-4214 Fire Arson Detection, which will be in <u>obsolete status as of August 14, 2023</u>.
  - Colleges should not use FIP-4214 (it has been removed from the attached Blue Sheet).
  - Colleges must download this change to local-college course libraries using the Colleague **XUIC** process and the Colleague **XULU** process to apply it to any local course copies.
    - Staff requiring assistance on the course download/update process should access the "Curriculum Management for Continuing Education User Guide" (KB0010403) in ServiceNow for a step-by-step guide.
- <u>Updated Blue Sheet</u>: A revised Blue Sheet is attached that incorporates the change noted above, plus other changes outlined previously in memo PS23-04 (attached).
  - Colleges should not use the course numbers listed in PS23-04 (they have been removed from the Blue Sheet).
  - Content previously offered using one of the obsoleted courses <u>may be appropriate for</u> offering under another FIP course number. Please contact Kenny Weatherington at weatheringtonk@nccommunitycolleges.edu if you have questions.
  - This replaces the previous *Blue Sheet* dated July 1, 2022.

The NCCCS *Blue Sheet* is provided to colleges as a desk reference of Workforce Continuing Education certification and non-certification courses with the following prefixes: FIP – Fire and Rescue; WLF – Wildland Fire; EPT – Emergency Management; and EME – Emergency Services.

The *Blue Sheet*, which is updated periodically, is provided by the NCCCS Public Safety Training Team for training purposes and general guidance only. The official sources for state certification information are the associated state agencies listed in the *Blue Sheet*.
